This work examines the role of interest groups in the creation and interpretation of the right to privacy, a highly controversial right that derived almost entirely from case law. It looks at amici participation in abortion, aid in dying, family relationships, and anti-sodomy cases. This volume tracks the influence of amici arguments and data on the Justices' handling of these cases.
